

AN ORDINANCE RELATING TO THE REGULATION AND CONTROL OF THE CITY CEMETERY OF THE CITY OF BONIFAY, FLORIDA, AND PROVIDING A PENALTY FOR THE VIOLATION OF THIS ORDINANCE.

BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF BONIFAY, COUNTY OF HOLMES, STATE OF FLORIDA:

Section 1. That the following rules and regulations of the City Council of Bonifay, Florida, hereby promulgated and set up and upon being signed shall govern the use and control of the City Cemetery of the City of Bonifay, Florida.

(a) No coping or any type of decorative bordering or trimming of any description shall be allowed around any grave or graves or cemetery lot or lots. Corner markers may be set provided said corner markers do not exceed six inches in diameter. No one shall be allowed to take in walk ways in order to join two or more lots together.

(b) The Cemetery Committee shall have exclusive duty of providing live plants and shrubbery, providing that no individual owner or owners of any cemetery lot may set out or plant any live plant or shrub on or adjoining any cemetery lot.

(c) All vaults shall be buried in such manner that they do not extend more than four inches above the normal level surface of the surrounding ground.

(d) Earth or Dirt which is removed from any grave or graves shall be hauled off the cemetery premises, provided that the cemetery committee may provide areas in the cemetery where excess dirt may be dumped.

Section 2. Any and all persons who shall violate any of the provisions of this Ordinance or fail to comply therewith shall be deemed guilty of a misdemeanor and upon conviction by the Municipal Court of the City of Bonifay, Florida, shall pay a fine of not more than Fifty (\$50.00) Dollars or be imprisoned in the City Jail for a term not to exceed Thirty (30) days.

Section 3. That should any part of this Ordinance be held invalid by a Court of competent jurisdiction, the remaining parts shall be severable and shall continue to be in full force and effect.

Section 4. That all Ordinances or parts of Ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as the same effect this Ordinance.

Section 5. That this Ordinance shall take effect and be in full force immediately after the passage and be signed by the President of the City Council and the Mayor of the City of Bonifay, Florida.
