ORDINANCE # 245

AN ORDINANCE PROVIDING RESTRICTIONS AGAINST THE OPERATION OF PRIVATE BOTTLE CLUBS WHICH DISPENSES ALCOHOLIC BEVERAGES WITHIN THE CITY LIMITS OF THE CITY OF BONIFAY, FLORIDA.

The City Council of the City of Bonifay, Florida does ordain as follows:

SECTION ONE

A private bottle club is one which allows alcoholic beverages to be brought on the premises by individuals and dispensed to said individuals with said individuals only paying for the ice and mixing ingredients.

SECTION TWO

Any building which has more than twenty (20) members who have in their possession at any time or on location in the building alcoholic beverages shall presume to be a private bottle club.

SECTION THREE

The dispensement of intoxicating liquor by a private bottle club shall not be allowed in the City of Bonifay if the proposed building is within two thousand five hundred (2,500) feet of a daycare center for children, a church or another place selling intoxication liquors.

SECTION FOUR

Each private bottle club must certify to the City Hall of Bonifay, Florida that it has no required State issued license and list the number of members in said private bottle club with its requirements for one to become a member of said proposed bottle club.

SECTION FIVE

The proposed building in which the proposed bottle club is situated must be one hundred feet (100) from the right of way of any public road.

SECTION SIX

No private club shall be opened past the time of 2:00am Sunday morning and shall not be opened until 7:00am on Monday morning and/or it must be closed on or before 2:00am Friday morning and shall not be allowed to reopen until 7:00am Saturday morning; and on Monday, Tuesday, Wednesday, and Thursday shall not be reopened until 7:00am Tuesday, Wednesday, Thursday, and Friday. Closed shall mean no members occupying the premises.

SECTION SEVEN

This ordinance is concerned with the dispensement of alcoholic beverages where one may make a profit by selling mixing ingredients for said beverages.

SECTION EIGHT

Intoxicating liquors- all liquors, wines or beer containing two (2) percent or more alcohol by weight shall be deemed and held to be intoxicating liquors, wines, or beer and subject to the provisions of this ordinance.

SECTION NINE

Anyone violating this ordinance shall be fined five hundred dollars (\$500.00) and/or shall be guilty of a misdemeanor of the second (2nd) degree, punishable in Section 775.082 or Section 775.083.

This ordinance shall take effect immediately upon its passage and signing.
