

ORDINANCE #257

AN ORDINANCE AMENDING ORDINANCE #200 BY AMENDING
SEWER RATES TO BE CHARGED FOR USE OF MUNICIPAL
SEWER SERVICES INSIDE AND OUTSIDE THE MUNICIPALITY

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF BONIFAY, FLORIDA, THAT:

SECTION 1. RATES, INSIDE CITY.

Section 4 of Ordinance #200 is Amended to read as follows:

- A. All residential users of the Sewer System shall pay a monthly rate of \$13.00.
- B. All commercial users of the Sewer System with less than two commodes shall pay a monthly rate of \$13.00 plus 60¢ per 1000. All commercial users with over two commodes shall pay a monthly rate of \$13.00 per commode plus 60¢ per 1000.
- C. All apartment houses, hospitals, nursing homes, housing projects shall pay a monthly rate of \$13.00 per room or rental unit, plus 60¢ per 1000, unless user can qualify under SECTION G of ORDINANCE #200.
- D. Public building users shall pay a monthly rate of \$13.00 per commode, plus 60¢ per 1000 (courthouse, hospital, health department) ~~churches~~. However, the City reserves the right to negotiate all rates with public agencies which require a heavy demand for sewer.
- E. Motels shall pay a monthly rate of \$7.00 per room, plus 60¢ per 1000.
- F. Schools shall pay the following rates:

Bonifay Elementary	\$321.00 plus 60¢ per 1000
Holmes Co. High	300.00 plus 60¢ per 1000
Holmes Jr. High (Middle School)	100.00 plus 60¢ per 1000
Gym	71.00 plus 60¢ per 1000
Hillcrest	108.00 plus 60¢ per 1000
Memorial Field	24.00 plus 60¢ per 1000
Agr. Building	29.00 plus 60¢ per 1000
Bus Barn	14.80 plus 60¢ per 1000
Health Department	14.80 plus 60¢ per 1000
Band Room	14.80 plus 60¢ per 1000

- G. Churches shall pay a monthly rate of \$7.00 per room, plus 60¢ per thousand

SECTION 2. All ordinances or parts of ordinances and all sections or parts of sections of the Code of Ordinances of the City of Bonifay not in conflict shall remain in full force and effect.

SECTION 3. EFFECTIVE DATE. This ordinance shall become effective on the 27 of March, 1990.
