

ORDINANCE # 292

AN ORDINANCE EXTENDING AND INCREASING THE CORPORATE LIMITS OF THE CITY OF BONIFAY, COUNTY OF HOLMES, STATE OF FLORIDA PURSUANT TO THE PROVISIONS OF FLORIDA STATUTES 171.044 ANNEXATION OF PROCEDURES BY ANNEXING THERETO CERTAIN TRACTS OF LAND CONTIGUOUS AND COMPACT AND NOT EMBRACED WITHIN THE PRESENT LIMITS OF THE CITY OF BONIFAY.

PROPOSED ANNEXED AREA

Commence at the Southwest Corner of NE 1/4 of SW 1/4 of Section 30, Township 5 North, Range 14 West and run North 345.8 feet; thence run East 750 feet for Point of Beginning; thence continue East 190 feet to the Westerly R/W line of State Road #79; thence run Northeasterly along R/W line 148.5 feet; thence run West 248 feet; thence run South 136 feet to the Point of Beginning, being Lot 1 and 50 feet of Lot 2, according to plat of survey made by Thomas E. Jenkins, Registered Land Surveyor.

SECTION ONE

The City Council hereby determines that the territory described does meet the criteria of Florida Statutes, and that such described territory is contiguous to the present City boundaries and compact and not embraced within the City of Bonifay has jurisdiction to annex the Territory described herein.

SECTION TWO

The City of Bonifay shall extend and provide all its urban services existing or which may be provided in the future to the area described in; Section Four hereof. The urban services shall be provided on the same basis as now existing within the City Limits and in the same manner of the City prior to annexation.

SECTION THREE

If any provisions of this Ordinance shall be held invalid, its invalidity shall not affect any other provisions of this

and for this purpose the provisions of this Ordinance are hereby declared to be severable.

SECTION FOUR

The corporate limits of the City of Bonifay are hereby extended and increased so as to include and embrace within the corporate limits of the city of Bonifay the following described territory and such City territory is hereby annexed and declared to be part of the City of Bonifay.

THE FOLLOWING DESCRIBED PROPERTY IS THE AREA TO BE ANNEXED
Commence at the Southwest Corner of NE 1/4 of SW 1/4 of Section 30, Township 5 North, Range 14 West and run North 348.8 feet, thence run East 750 feet for Point of Beginning; thence continue East 190 feet to the Westerly R/W line of State Road #79; thence run Northeasterly along R/W line 148.5 feet; thence run West 248 feet; thence run South 136 feet to the Point of Beginning, being Lot 1 and 50 feet of Lot 2, according to plat of survey made by Thomas E. Jenkins, Registered Land Surveyor.
