AN ORDINANCE ANNEXING W 3/4 OF S 1/2 OF S 1/2 of NW 1/4 of NW 2 ALSO COMMEMCE AT THE NE COR. OF SW 2 OF NW2 AND RUN W. 186 FT. TO THE POINT OF BEGINNING, THENCE CONTINUE W. 410 FT., THENCE S. 165 FT., THENCE E. 410 FT, THENCE N. 165 FT. TO THE POINT OF BEGINNING, OF SECTION 7, TOWNSHIP 4 NORTH, RANGE 14 WEST AND THE W 2 OF N 2 OF S OF NW 2 OF NW 2 OF SECTION 7, TOWNSHIP 4 NORTH, RANGE 14 WEST, LOCATED IN HOLMES COUNTY, FLORIDA, TO THE CITY OF BONIFAY, A MUNICIPAL CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA, AND WHICH LAND IS CONTIGUOUS TO SAID MUNICIPALITY AND THE BOUNDARY LINES OF SAID MUNICIPALITY SHALL INCLUDE THE LAND DESCRIBED HEREIN: AND PROVIDE AN EFFECTIVE DATE.

W 3/4 of S $\frac{1}{2}$ of NW $\frac{1}{4}$ of N/W $\frac{1}{4}$ also commence at the NE Corner of SW $\frac{1}{4}$ of NW $\frac{1}{4}$ and run W. 186 ft. to the Point of Beginning, thence continue W. 410 ft. thence S. 165 ft., thence E. 410 ft., thence N 165 ft. to the Point of Beginning of Section 7, Township 4 North, Range 14 West and the W 1/2 of N $\frac{1}{2}$ of SV of SW $\frac{1}{4}$ of Section 7, Township 4 North, Range 14 West, located in Holmes County, Florida.

which land is cotiguous to the City of Bonifay, a municipal corporation, be and the same is annexed to said municipality and the boundary lines of said municipality shall include the land described herein.

Section 2. That all ordinances or parts of ordinances conflicting with provisions of this ordinance are hereby repealed insofar as the same effect this ordinance,

Section 3. That this ordinance shall take effect and be in full force immediately after the passage and be signed by the Chairman of the City Council and the Mayor of the City of Bonifay, Florida.
