

ORDINANCE # 213

AN ORDINANCE IMPOSING LICENSE TAXES FOR THE CONDUCT OF BUSINESS, OCCUPATIONS AND PROFESSIONS IN THE CITY OF BONIFAY, IN HOLMES COUNTY, FLORIDA, DEFINING TERMS USED THEREIN MAKING IT UNLAWFUL FOR ANY PERSON TO CONDUCT ANY BUSINESS, OCCUPATION OR PROFESSION ENUMERATED IN SAID ORDINANCE WITHOUT PAYING A LICENSE TAX AS PROVIDED IN SAID ORDINANCE; DESIGNATING THE TIME WHEN OCCUPATIONAL LICENSE TAXES SHALL BE DUE AND PAYABLE AND PROVIDING FOR HALF-YEAR LICENSE; PROVIDING PENALTIES FOR DELIQUENT PAYMENT OF TAXES; PROVIDING FOR THE TRANSFER OF LICENSES; PROVIDING THAT THE PAYMENT OF LICENSE TAXES IMPOSED BY SAID ORDINANCE SHALL NOT BE AN EXEMPTION FROM OTHER FORMS OF TAXATION; REQUIRING ALL OFFICERS AND AGENTS OF ALL CORPORATIONS COMPLY WITH THE PROVISIONS OF SAID ORDINANCE, AND SUBJECTING ORDINANCE; PROVIDING THAT THE CITY CLERK SHALL FIX THE AMOUNT OF LICENSE OF ANY PERSON WHO SHALL NOT HAVE IN HIS POSSESSION OR UNDER HIS CONTROL IN THE CITY A TRUE RECORD OF BUSINESS TRANSACTED; PROVIDING FOR THE REVOCATION AND CANCELLATION OF LICENSES; PROVIDING SKILLS, CONDITIONS AND QUALIFICATIONS OF LICENSES REPEALING ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH, PROVIDING FOR THE ENFORCEMENT OF THE PROVISIONS OF SAID ORDINANCE, PROVIDING PENALTIES FOR THE VIOLATION THEREOF AND RECITING THE EFFECTIVE DATE.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BONIFAY, IN HOLMES COUNTY, FLORIDA:

Section 1. DEFINITIONS. For the purpose of this ordinance, words used herein shall have the following meaning:

MERCHANDISE: Any goods, wares, or commodities bought or sold in the usual course of trade.

MERCHANT: Any person engaged in the business of selling merchandise at retail or wholesale.

SALE: The transfer or ownership, title or possession, transfer, exchange or barter, whether conditional or otherwise, for a consideration.

Section 2. LICENSE REQUIRED: Payment of tax, compliance with Chapter.

It shall be unlawful for any person, firm or corporation to exercise any of the privileges or to carry on or engage in or conduct any of the businesses, occupations or professions, herein specifically enumerated without paying a license tax at the time and in the amount herein provided, or fail to make reports to the City Clerk as provided herein, or to violate any other provision of this ordinance.

Section 3. WHEN LICENSE IS DUE AND PAYABLE: HALF-YEAR LICENSES. The license taxes required by this ordinance shall be due and payable on the first day of October of each year unless otherwise provided herein, except a business that shall begin between April first and September thirtieth, may secure a one-half year license for one-half the amount:

Section 4. PENALTY FOR DELINQUENT PAYMENT OF LICENSE TAXES. There will be a \$5.00 per day penalty beginning with the first day of November until license is purchased. Nothing in this section, however, shall be construed as being a bar or waiver of the right of prosecution or enforcing any other penalty provided by ordinance, or otherwise provided by law.

Section 5. EACH LOCATION TO HAVE SEPARATE LICENSE. If any person operates any of the businesses provided for herein at more than one location, each location shall be considered a separate business and a separate license therefore is required unless otherwise provided for herein.

Section 6. ISSUANCE OF LICENSES; SIGNING; RECORDING OF LICENSES. All licenses shall be made out and issued by the City Clerk and/or deputy upon payment of the license tax, and shall be signed by him and a list of all such licenses shall be preserved, showing the date of issuance, the name of the party to whom issued, the number of the license and the nature of the business and occupation licensed.

Section 7. TRANSFER OF LICENSES. Unless otherwise provided herein, all licenses issued by the City may be transferred upon the approval of the City

Clerk with the business for which they are taken out, when there is a bona fide sale and transfer of the property used and replaced in the business as stock-in-trade, but such transferred license shall not be good for any longer time or for any other place than that for which it was originally issued.

Whenever the City Clerk has approved the transfer of any licenses under the provisions of this section, it shall be the duty of the transferee to produce such license to the City and thereupon the City Clerk shall make proper entry showing such transfer.

Section 8. PAYMENT OF LICENSE TAX NOT TO EXEMPT OTHER FORMS OF TAXATION ON PROPERTY. Licenses imposed and collected by this ordinance shall not be construed to exempt forms of taxation property used in the licensed business or occupations.

Section 9. DUTY OF OFFICERS, AGENTS, ETC., OF CORPORATION TO COMPLY WITH ORDINANCE. It shall be the duty of all officers and agents of all corporations to see that all corporations comply with the provisions of this ordinance; and all officers or agents of any corporation required by this ordinance to be licensed, which shall carry on or conduct any business without having made the payment and otherwise complied with the terms of this ordinance shall be subject to the same penalty or penalties imposed upon persons violating the provisions of this ordinance. The members of any firm who fail or refuse to comply with the provisions of this ordinance shall likewise be subject to the same penalty or penalties imposed upon persons violating the provisions hereof. In the absence of any owner, proprietor, manager or agent, any person operating or in charge of any business being conducted without the requirements of this ordinance having been complied with, shall be subject to the same penalty or penalties imposed upon persons violating provisions of this ordinance.

Section 10. MANUFACTURER SELLING FROM PLACE OF MANUFACTURE. A manufacturer engaged in business in this City not otherwise designated herein as being specifically subject to a merchant's license (see definition of a merchant herein)

may without a merchant's license, sell at the place of manufacture, the goods, wares and merchandise manufactured by him at the place of manufacture. When such manufacturer sells at or from a different place or store other than the place of manufacture, he shall be considered a "merchant" and his license shall be based on sales made from such other different place or store.

Section 11. EFFECT ON OTHER ORDINANCES. Nothing herein contained shall be deemed as repealing or modifying the requirements of any other ordinance which provides for the securing of any ordinance of the City, except such ordinances as are specifically hereby repealed, or which are in conflict herewith.

Section 12. LICENSE TAXES-AMOUNTS. A license tax is hereby levied upon and shall be collected from every person, firm or corporation exercising the privileges of carrying on or engaging in the businesses, professions or occupations hereinafter specifically enumerated in the amounts as fixed hereinafter; each such amounts, unless otherwise specifically stated, being the amount payable as a license tax for exercising such privileges or carrying on or engaging in such business, profession or occupation mentioned for each, and it shall be unlawful for any person, firm or corporation to carry on or engage in any business, occupation or profession herein prescribed and designated without having first paid the license tax as provided herein or complied with the terms hereof as follows:

ABATTOIR- Animal slaughter house, per year, \$25.00.

ABSTRACT COMPANIES- Person or persons, firms, corporations or associations preparing abstracts and charging a fee therefor or giving legal advice with same, per year, \$30.00.

ADDING MACHINES, DICTAPHONES AND THE LIKE, AGENTS AND/OR SALESMEN, per year, \$25.00.

ADVERTISING AGENTS OR SOLICITORS, Per year, \$20.00.

ADVERTISING ON CURTAINS IN THE THEATRES OR PLACES OF PUBLIC AMUSEMENT OR
THROWING SIGN ON CURTAIN, per year, \$25.00.

AGENCY, COMMERCIAL, or person, firms, corporations or associations, other
than lawyers, giving information as to credit rating or standing of individuals
or firms, per year, \$20.00.

AGENCY, REAL ESTATE SALES, per year, \$25.00.

AGENCY, RENTAL OR COLLECTING, per year, \$15.00; for each additional
solicitor and/or collector, per year, \$15.00.

AGENCY, INSURANCE (see insurance).

AGENCY, AND/OR AGENTS FOR OTHER BUSINESSES NOT SPECIFICALLY MENTIONED,
per year, \$25.00.

AGENCY, SELLING STAMPS TO MERCHANTS FOR SALES PROMOTION PURPOSES, per year,
\$100.00.

AGENTS, FOR THE LEASING OF LINENS, per year, \$25.00.

AGENTS, FIRMS, ASSOCIATIONS, CORPORATIONS OR ANY OTHER PERSONS DISTRIBUTING
CIRCULARS, pamphlets or other advertising matter for persons, firms or corpor-
ations who are not licensed by the City to carry on the business thus advertsed,
per day, \$5.00.

AGENTS, FOR MARBLE OR STONE QUARRY OR YARDS, Per year, \$25.00; unless in con-
nection with established business paying other license.

AGENTS, FOR SALE OR STOCKS AND BONDS, per year, \$10.00.

AIRPLANES FOR HIRE, per year, \$100.00.

ANIMAL HOSPITAL, per year, \$25.00.

AQUARIUMS AND PET SHOPS, per year, \$25.00.

ARCHITECTS AND SUPERINTENDENTS OF BUILDINGS, per year \$15.00.

ASTRONOMERS on streets, charging fees, per week, \$25.00.

ATTORNEYS, per year, \$25.00.

AUDITING COMPANIES, AUDITORS AND ACCOUNTANTS, per year, \$25.00.

AUCTIONEERING, no license to be issued to a firm or corporation, but in each
case to one person named who shall personally do the auctioneering, per year, \$30.00.

AUTOMOBILE DEALERS, including shops connected, per year, \$50.00.

AUTOMOBILES, OUTDOOR PARKING LOT, per year, \$20.00.

AUTOMOBILE GARAGE and/or Fender and Body Works, per year, \$25.00, when not in connection with auto dealer.

AUTOMOBILE TIRE REPAIRERS and/or Mechanical Adjustors, not paying regular garage or service station license, or auto dealer license, per year, \$15.00.

AUTOMOBILE OPERATORS OR DRIVERS OF ANY TAXI CAB, taxibus Automobile, Truck or other motor vehicle carrying passengers for hire as follows: each vehicle, per year \$35.00. (See Taxi Cab).

AUTOMOBILE LAUNDRY OR WASHING AND GREASING, not operated in connection with other business per year, \$25.00.

AUTOMOBILE AND/OR TRUCK FOR HIRE, per year, \$15.00.

AUTOMOBILE PARTS, per year, \$35.00.

AUTOMOBILE U-DRIVE-IT, per year, \$15.00.

AUTOMOBILE, PAINTING, Per year, \$15.00.

AUTOMOBILE, MOVING VAN, per year, \$25.00.

AUTOMOBILE, STORAGE PLACES FOR RENT, per year, \$25.00.

AUTOMOBILE, ADVERTISING FOR PROFIT, with or without loud speaker, per day, \$5.00. or \$100.00 per year.

AWNING MANUFACTURERS OR ERECTORS, per year, \$15.00.

BALL MACHINES, MARBLE MACHINES, PIN GAMES, and other games and machines not specifically covered by machine must be bought for its serial number and license securely attached to each machine so that it cannot be removed for substitution on another machine.

BALL, CONCERTS, ENTERTAINMENTS OR EXHIBITIONS for which admission is charged

(except for church and school purposes) for each performance, exhibition or entertainment, \$5.00.

BANKS, BANKING INSTITUTIONS, per year, \$25.00.

BARBER SHOPS, PER CHAIR, per year, \$20.00.

BARREL FACTORIES OR COOPER SHOPS, per year, \$25.00.

BEAUTY PARLORS, per year, \$25.00.

BEER AND WINE, wholesale and retail, per year, \$15.00.

BICYCLE AND MOTORCYCLE REPAIRS, only one license required for both occupations, per year, \$10.00.

BILLIARD, TOOL, BAGATELLE AND JENNY LIND TABLES, when kept and set up for other than private use, whether operated or not first, \$25.00 and each additional table at \$12.50 each per year.

BLACKSMITH SHOP, per year, \$10.00.

BILL POSTING SIGNS OFF PREMISES, where business is operated \$2.00. per board.

BONDING COMPANIES, GUARANTY AND SURETY COMPANIES, or persons firms or corporation engaged in the business of making bonds for profit, per year, \$100.00.

BOOK AGENTS OR CANVASSERS FOR THE SALE OF BOOKS maps, periodicals, magazines, stationary and the like, per year, \$25.00.

BOOT BLACK STANDS (see shoe shine stands).

BOOT AND SHOE MAKERS OR REPAIRERS, when not included in retail sales, per year, \$20.00.

BOOT AND SHOE DEALERS, SECOND HAND, per year, \$20.00.

BOWLING ALLEYS, for each alley, per year, \$25.00.

BOX AND CRATE FACTORIES, per year, \$25.00.

BRICK OR STONE DEALERS, manufacturers or agents for the sale of brick or stone or cement products, including those soliciting orders for or having an office in the City and whom shall personally or as the agent servant or employee

of another or in any capacity whatever, otherwise than as the duly authorized representative of the federal government, employ influence, solicit, recruit or entice laborers for work at any place outside of the State of Florida, per year, \$500.00.

BROADCASTING OR RADIO STATION, per year, \$25.00.

BROKERS, LABOR, for each person, firm or corporation who shall engage in the business of emigrant agent, or who shall personally or as the agent servant or employee of another, or in any capacity whatever, otherwise than as the duly authorized representative of the federal government, employ, influence, solicit, recruit or entice laborers for work at any place outside of the State of Florida, per year, \$500.00.

BROKERS, OR OTHERS SELLING FRUITS, VEGETABLES OR MERCHANDISE exclusively from railroad cars, trucks or boats, from each car, truck or boat, per year, \$25.00.

BROKERS, not otherwise included herein, per year, \$25.00.

BUILDERS OF BOAT AND SHIP BUILDING COMPANIES less than 10 hands, per year, \$10.00; when employing 10 and not over 50 hands per year, \$10.00; when employing 51 or more, per year, \$20.00.

BUILDERS SUPPLIES (see merchants).

BUILDERS OF HOUSES FOR RESALE, Per year, \$25.00.

BUILDING AND LOAN ASSOCIATION OR AGENTS THEREOF, domestic, per year, \$25.00.

BURIAL VALTS OR OTHER CONCRETE PRODUCTS MANUFACTURED FOR SALE, other than building unit, Per year, \$25.00.

BUS STATIONS, where buses are parked on streets, per year, \$50.00.

BUS TERMINAL, where buses are parked elsewhere than on streets, per year, \$25.00.

BUS TICKET OFFICE, when not connected to other licensed business, \$25.00.

BUSINESS COLLEGES, per year, \$12.50.

BUTCHERS, wholesaling meats, per year, \$25.00.

CABINETS SHOPS, per year, \$25.00.

CANDY MANUFACTURERS, wholesale or retail, per year, \$25.00.

CANE RACKS, KNIFE LIFTING MACHINES, STRIKING MACHINERY, MERRY-GO-ROUND,
and similar amusements of same class per day, \$5.00 each (no exceptions).

CANVASSERS, FOR TOILET ARTICLES AND MEDICAL SUPPLIES, per year, \$50.00.

CANVASSERS, REPRESENTING FOREIGN FIRMS and corporations soliciting orders

CLOTHING, SECOND-HAND DEALERS in, subject to the same regulations as pawn brokers, per year, \$25.00.

CLEANING, Dry-pick up and Delivery station only, per year, \$20.00.

COAL YARDS, per year, \$12.50.

COFFEE ROASTERS, when not in connection with other licenses business, per year, \$2.50.

COLD STORAGE PLANTS, per year, \$25.00.

CONTEST COMPANIES, persons, firms associations or corporations conducting contests by offering premiums or other inducements for advertising purposes or for the purpose of stimulating or increasing trade, for each sale or contest per year, \$25.00.

CONTRACTORS, ELECTRICAL, from and after the effective date of this ordinance, no person, firm, partnership or corporation shall, within the City of Bonifay do any type of electrical contract work as defined in F.S. 489.505 (8) without first presenting a sworn statement to the City of Bonifay that he has been actively engaged as an electrical contractor for the past five consecutive years in the City of Bonifay. The statement shall further be acknowledged by two residents of the City of Bonifay that they have known the applicant for five years and that he has been engaged in electrical construction; Or the applicant shall give proof that he has successfully completed a course in the electrical field through a recognized vocational school, college or trade school.

Upon the completion of the above acts, the acts or conditions he shall then obtain a license as defined by F.S. 489.513 which means a registered electrical contractor from the Department of Professional Regulation, an electrical contractor's licensing board whereupon the City shall issue a license upon payment of \$50.00.

The electrical contractor shall be required to maintain active certification with said department while he is engaged as an electrical contractor and give proof of his certification to the City of Bonifay within _____ days of notice by the City of Bonifay

Any person or persons, firm, partnership, or corporation violating any of these provisions of this ordinance shall result in a suspension of his occupational license and an imposition of and administrative fine of \$1,000.00.

It is provided herein that proof of certification from the Department of Professional Regulation shall dispense with all conditions in the above paragraph excepting this fee.

No part of this ordinance shall excuse or relieve the electrical contractor from violating any portion of F.S. 489.533 (1983).

CONTRACTORS, PLUMBING, From and after the effective date of this ordinance, no person, firm, partnership or corporation shall, within the City of Bonifay do any type of plumbing contract work as defined in F.S. 489.105 (3) (M) without first presenting a sworn statement to the City of Bonifay that he has been actively engaged as a plumbing contractor for the past five consecutive years in the City of Bonifay. The statement shall further be acknowledged by two resident of the City of Bonifay that they have known the applicant for five years and that he has been engaged in plumbing construction; or the applicant shall give proof that he has successfully completed a course in the plumbing field through a recognized vocational school, college or trade school.

Upon the completion of the above acts the acts or conditions he shall then obtain a license as defined by F.S. 489.117 which means a registered plumbing contractor from the Department of Professional Regulation Board whereupon the City shall issue a license upon payment of \$50.00.

The plumbing contractor shall be required to maintain active certification with said department while he is engaged as a plumbing contractor and give proof of his certification within ____ days of notice by the City of Bonifay,

Any person, or persons, firm, partnership, or corporation violating any of these provisions of this ordinance shall result in a suspension of his occupational license and an imposition of an administrative fine of \$1,000.00.

It is provided herein that proof of certification from the Department of Professional Regulation shall dispense with all conditions in the above paragraph, excepting this fee.

No part of this ordinance shall excuse or relive the plumbing contractor from violating any portion of F.S. 489.129.

GAMES, such as shuffleboards, throwing balls at figures and the like, for profit, per machine, per year, \$25.00.

GARAGES, not selling automobiles or trucks and not selling parts, except as replacements on vehicles serviced by said garage, per year, \$25.00.

GASOLINE and petroleum products dealers, per year, \$25.00.

GASOLINE AND petroleum products dealers, wholesale up to 25,000 gallons, \$30.00; from 25,000 gallons to 50,000 gallons, \$45.00; from 50,000 gallons up, \$75.00.

GAS COMPANIES, selling fuel and heating or cooking gas appliances, per year, \$25.00.

GRAVEL SAND DEALERS, agents and salesmen, per truck, per year, \$15.00.

HAWKERS OR VENDERS OF MEDICINES, drugs or patent medicines or other preparations purporting to possess medical virtues (other than licensed pharmacists) and hawkers or peddlers who occupy any part of the street or sidewalk by displaying or crying their wares, or who, by music or other entertainment or garnage endeavor to attract crowds for the purpose of selling their wares, per day, \$25.00 (non-exempt).

HERBALISTS AND OTHERS, except duly licensed physicians, professing to cure disease, injuries or deformities by drugs, ointments, expediments or devices of any kind, per year, \$50.00.

for accomodations for:

from 5 to 9 rooms, \$25.00. per year.

from 10 to 29 rooms, \$50.00. per year.

from 30 to 49 rooms, \$60.00 per year.

from 49 rooms up, \$75.00 per year.

If meals are served, a restaurant license must be taken in addition.

HOUSE MOVERS, per year, \$50.00.

Section 13. ENFORCEMENT BY SEIZURE. The payment of license taxes may be enforced by the seizure and sale of the property engaged in the business, occupation or profession upon which such a license taxes are imposed, and the City Clerk may issue a Distress Warrant in the name of the State and/or City for the collection of the license tax. Such Warrant may be executed by the Chief of Police or any police officer of the City or by any other method provided by law.

Section 14. PENALTY FOR VIOLATIONS. Any person engaged in or continuing a business occupation or profession, who shall violate any of the terms or provisions of this ordinance, shall upon conviction thereof, be punished by a fine of not more than \$200.00 or by imprisonment in the municipal jail for not to exceed 60 days, or by both such fine and imprisonment in the discretion of the Mayor; and provided that each day any such person shall fail to report as required by this ordinance, such failure shall be considered a separate offense, and any person who is required by this ordinance to furnish information who shall be guilty of furnishing false information shall be guilty of a violation of this ordinance and subject to the penalties here provided.

Section 15. OCCUPATIONS FALLING INTO MORE THAN ONE CLASSIFICATION. When any occupation, business, profession or privilege shall fall into more than one of the classifications contained in Section 12 hereof, such occupation, business, profession or privilege shall be required to comply with the license required of each classification of privilege unless otherwise stated by such classification.

Section 16. REVOCATION AND CANCELLATION OF LICENSES. In addition to any other penalties provided for herein, and in addition to any other remedy herein provided for the enforcement of this ordinance, any person, firm or corporation violating any of the provisions of this ordinance, shall be subject to having his, her or its license revoked and cancelled. Upon the conviction of any person, firm or corporation of the violation of any of the terms or provisions of this ordinance, the City Clerk may thereupon, in his discretion, revoke and cancel the license of such person, firm or corporation so convicted, and the renewal or reissuance of such license prior to the end of the fiscal year in which issued, shall be in the discretion of and by action of the City Council.

Section 17. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section 18. DECLARATION OF INTENT. If any section, sub-section sentence, clause, phrase or word of this ordinance shall for any reason be held or declared unconstitutional, invalid, inoperative, ineffective or void, such invalidity or unconstitutionality shall not be construed to affect the portions of the ordinance not so held to be unconstitutional, void, invalid or ineffective, or affect the application of this ordinance to other circumstances not so held to be invalid, it being hereby declared to be the express intent of the City Council of the City of Bonifay, Florida, that any such unconstitutionality, illegal, invalid, ineffective or void portion or portions of this ordinance did not induce its passage and that without the inclusion of any such unconstitutional, illegal, invalid, ineffective or void portions of this ordinance the City Council would have enacted the valid and constitutional portions thereof.

Section 19. TIME OF TAKING EFFECT. This ordinance shall take effect immediately upon its becoming a law. Passed in open and regular session of the Council of the City of Bonifay, in Holmes County, Florida this ____ day of _____, 19 .
