AN ORDINANCE EXTENDING AND INCREASING THE CORPORATE LIMITS OF THE CITY OF BONIFAY, COUNTY OF HOLMES, STATE OF FLORIDA PURSUANT TO THE PROVISIONS OF FLORIDA STATUES 171.044 ANNEXATION OF PROCEDURES BY ANNEXING THERETO CERTAIN TRACTS OF LAND CONTIGUOUS AND COMPACT AND NOT EMBRACED WITHIN THE PRESENT LIMITS OF THE CITY OF BONIFAY.

PROPOSED ANNEXED AREA

NE 1/4 of NW 1/4 LESS A PARCEL to begin at the NE Corner and run West 83 yards, South 83 yards, East 83 yards, North 83 yards to Point of Beginning LESS 12.45 acres described in OR BOOK 105, PAGE 188, OR BOOK 194, PAGE 627-629, and OR BOOK 196, PAGE 729 of the Public Records of Holmes County, Florida. IN SECTION 36 T5N R15W.

SECTION ONE

The City Council hereby determines that the territory described does meet the criteria of Florida Statutes, and that such described territory is contiguous to the present City boundaries and compact and not embraced within the City Limits; and therefore the City Council of the City of Bonifay has jurisdiction to annex the territory described herein.

SECTION TWO

The City of Bonifay shall extend and provide all its urban services existing or which may be provided in the future to the area described in Section Four hereof. The urban services shall be provided on the same basis as now existing within the City Limits and in the same manner of the City prior to annexation.

SECTION THREE

If any provisions of this Ordinance shall be held invalid, its

invalidity shall not affect any other provisions of this Ordinance that can be given effect without the invalid provision, and for this purpose the provisions of this Ordinance are hereby declared to be severable.

SECTION FOUR

The corporate limits of the City of Bonifay are hereby extended and increased so as to include and embrace within the corporate limits of the City of Bonifay the following described territory and such City territory is hereby annexed and declared to be part of the City of Bonifay.

THE FOLLOWING DESCRIBED PROPERTY IS THE AREA TO BE ANNEXED

NE 1/4 of NW 1/4 LESS A PARCEL to begin at the NE Corner and run West 83 yards, South 83 yards, East 83 yards, North 83 yards to Point of Beginning LESS 12.45 acres described in OR BOOK 105, PAGE 188, OR BOOK 194, PAGE 627-629, and OR BOOK 196, PAGE 729 of the Public Records of Holmes County, Florida.
