ORDINANCE NUMBER 81

AN ORDINANCE ENTITIED" AN ORDINANCE PROGIBITING THE RUNNING AT LARGE ON THE PUBLIC STREETS, ALLEYS OR UNINCLOSED LANDS OR LOTS IN THE CITY OF BONIFAY, FLORIDA, OR ANY ANIMAL OF THE BOVINE SPECIE, INCLUDING SHEEP AND GOATS, AND PROVIDING PENALITIES FOR VIOLATIONS" THEREOF, AND PROVIDING IMPOUNDUNG FEES TO BE COLLECTED, AND OTHER PURPOSES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BONIFAY, FLORIDA.

Section1. That from and after the passage and approval of this ordinance it shall be unlawful for any animal of the bovine specie, including sheep or Goats, to run at large upon the Public Streets, Alleys or Uniclosed lands or lots in the City of Bonifay, Florida.

Section 2. That any animal of the Bovine Specie, Sheep or Goats found running at large in the City of Bonifay in violation of Section 1, of this ordinance, shall be impounded by the City Marshall or by some one at this direction, appointed by him for that purpose, in the municipal pound of the City of Bonifay, and all not be released therefrom until the owner or other person claiming such animal shall pay therefor the following named fees to wit;

To which fees shall be added the further sum fifty cents per day for the feed of each animal of the bovine species, and sum of seventy-five cents each per day for the feed of each sheep or Goat.

Section 3. That immediately upon the impounding of any such animal or animals, the City Marshall shall give notice to the owner, if known and if such owner does not redeem the enimal or animals within twenty-four hours from the time such notice is given him by paying the fees and expenses as herein provided for, then the Marshall shall proceed to advertise immediately for sale of such animals or animal so impounded by posting notice for such sale at three public places in the City of Bonifay, or by publishing notice of such sale for one issue in a weekly newspaper published in said City, that such will be he;d at the expiration of seven days from said posting of such notice or from the publishing such notice of sale in said newspaper; in the event the owner is unknown, such notice shall be given immediately upon impounding the said animal or animals, and shall be sold at the expiration of such notice by the City Marshall at public sale to the highest bidder before the Pound Pen in the City of Bonifay, the proceeds of the sale to be applied first to the payment of the fees aforesaid and the expense of impounding, keeping and sale, and the balance, if any, shall be paid to the owner if known, and if

Section 4. That all ordinances and parts of ordinances in conflict with the provisions of this ordinance be, and the same are, hereby repealed.

Section 5. That this ordinance shall take effect on the first day of April A.D. 1924, and after its passage and approval by the Mayor of the City of Bonifay, Florida
