## ORDINANCE NUMBER 91

AN ORDINANCE PROVIDING FOR THE CONSTRUCTION OF SIDEWALKS ALONG CERTAIN STREETS IN THE CITY OF BONIFAY, FLORIDA, AND PROVIDING THAT THE PROPERTY BENEFITIED THEREBY SHALL BE ASS\_ ESSED FOR ITS PROPORTION OF THE EXPENSE THEREOF, AND THAT SUCH ASSESSMENT SHALL CONSTITUTE A LIEN UPON SUCH PROPERTY PRIOR IN DIGNTY TO ALL OTHER LIENS EXCEPT LINS FOR ASSESSED TAXES, AND PROVIDING FOR THE ISSUANCE OF CERTIFICATES OF INDEBTEDNESS.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BONIFAY, FLORIDA.

Section 1. That sidewalks shall be constructed under the direction of the said City of Bonifay on both sides of the following named streets and avenues in said City for the distances herein set out, except that no sidewalks shall be constructed across any streets, to-wit:

North Depot Street-between Pennsylvanis Avenue and L. & N. Railroad, right-of-way.

Hamlin Street-between Kanas Avenue and Indiana and between Iowa Avenue and Kansas Ave.

Evans Avenue- between State Street and Hubbard Street

Pennsylvania Avenue- between Waukesha Street and Tracy Street.

Indiana Avenue- Between Waukesha Street And Tracy Street. .

Michigan Avenue- between Waukesha Street and Oklahoma Street.

and sidewalks shall be constructed under the direction of said City on the following named streets and avenues in said City for the distances herein set out, except that no sidewalks shall be constructed across any streets, to-wit:

Iowa Avenue on North side- between Oklahoma Street and Hubbard Street.

Hubbard Street on West Side- between Nebrasla Avenue and a point 140 feet North Of Kanasa Avenue.

Railroad Avenue (Old Caryville- Bonifay Road) Commencing at north end of Depot Street and running in an easterly direction approximately 300 feet on the South side of said Avenue

Section 2. All said sidewalks shall be constructed of concrete mixed in the proportion of one part of Portland Cement, two and one-half parts of fine aggregate and four parts of course aggregate, amd additional specification shall be adopted by the City Council and filed in the office of the Clerk of said City of Bonifay, prior to the commencement of the construction work.

Section 3. Said sidewalks be four inches thick, and five feet wide except as hereinafter provided.

Section 4. That the expense of the construction of said sidewalks shall be assessed on the property benefited by said sidewalk improvements in the following manner:

By assessing on each lot or parcel of land sbutting and vordering upon said sidewalks a proportionate share of the total expense and cost of said sidewalks according to the number of lineal front feet bordering and abutting on said sidewalks, and according to the width of said sidewalks.

Section 5. Upon the assement for said sidewalks improvements being made the City of Bonifay shall issue certificates of indebtedness for the amount assessed on said abutting

and bordering property, separate certificates to be issued against each tract of land as assessed, as provided by Section 1906 Revised General Statutes of Florida, said certificates to be payable in ten equal annual installments with interest at the rate of eight per cent per annum payable annually from the date of the issuance of said certificates. Said certificates shall be governed by all the provisions of said Section 1906 and the City Council may, in its discretion, issue improvement bonds as provided in Section 1907 zevised General Statutes of Florida.
