## ORDINANCE NUMBER 96

AN ORDINANCE IMPOSING LICENSE AND OTHER TAXES，PROVIDING FOR THE PAYMENT THERE OF，AND PRESCRIBING PENALTIES FOR DOING BUBINESS WITHOUT A LICENSE，OR OTHER FAILURE RO COMPLY WITH THE PROVISIONS THEPEOF。

BE IT ORDAINED BY THE MAYOR，AND THE CITY COUNCIL OF THE CITY OF BONIFAY，FLORIDA．
Section 1．No person，firm or coroporarion in the City of Bonifay，Florida shall engage in or manage the business，profession or occupation mentioned im this ordinance unless a City License shall have been procured from the City Clerk，which amount here－ inafter provided，and to which shall be affixed the seal of the City of Bonifay，Florida and shall entitle such person，firm or corporation to engage in the business，profes－ sion or occuption named therein，every word importing the singuler number in this ordinance shall be construted and extended to apply to the plural and every word in quoting the plural number may be constructed and extended to apply to the singular number，and every word in quoting the mascline gender only may be construed and ex－ tended to and applied to famales as well as males．

Section 2．No license shall be issued for a longer period than one year，and all license shall expire on the last day of October each year，but fractional license may be issued to expire on that date at an appropriate rate，provided that no license shall be issued for less than half of the amount hereafter poovided as their license for one year．

Section 3．All licenses shall be due and payable．in advance before the first day of November of each year，and no license shall be issued for any fractional part of a year except that any license not otherwise specified in this ordinance may be issued after the first day of may to expire the last day of October，upon payment of one half of the amount fixed as the price of such licenses for one year．

Any person or persons, firm coporation of association that shall carry on or conduct any business or profession of which a licanse is required by this Ordinance without first obtained such license, shall be guilty and upon conviction shall be punished by a fine not more than double the amount required for such license, the payment of a,ll license tax shall be enforced by seizure and sale of the property by the Chief of police and it is hereby made the duty $\Phi 1$ the Chief of Police to report to the Mayor and Board of Councilmen any Violation ef this ordinance.

Every City license shall be frunished by the City Clark under the City Corporate Seal under his mand upon blanks furnished by the City Councilmen, and the persons obtaining such license shall keep sich license conspiciously exhibited at their place of business, and upon failure to do so shall be subjected to pay another amount and take out another licenses for the business conducted.

Section 216. Any person or persons firm or corporation or association delinquent for more than thirty (30) days from November, lst in the payment of a license sha, 11 berequired to pay a penalty $\operatorname{Diff}^{\text {fifty ( }} 50$ ) percent of the amount of such license, and any person or persons fidrm or corporation or association engaging in or carrying on any business within the City of Bonifay, Florida, for more than sixty (60) days without procuring a license required shall be deemed and held guilty of a misdeamor and upon conviction shall be fined not exceeding thirty(30) days.

Section 217. All Ordinances and parts of the $\phi$ rdinances in conflict with this Ordinance is hereby repeaked.

This Ordiaance shall be in full force and effedt immediately after its passage by the board of Councilmen and approval by the Mayor.
