AN ORDINANCE ENTITLED "AN ORDINANCE VESTING IN THE CITY CLERK OF THE CITY OF BONIFAY, FLORIDA, THE AUTHORITY, AND REQUESTED OF HIM TO PERFORM THE DUTIES OF CITY TAX ASSESSORS AND VESTING IN THE CITY MARSHALL OF THE CITY OF BONIFAY, FLORIDA, THE AUTHORITY, AND REQUESTING OF HIM TO PERFORM THE DUTIES OF CITY TAX COLLECTOR.

BE IT ORDAINED, BY THE MAYOR, AND CITY COUNCIL OF THE CITY OF BONIFAY, FLORIDA.

Section 1. That on and after the passage and approval of this Ordinance, the City clerk of bonifay, Florida shall be vested with the authority of city Tax Assessor and in addition to the duties of City Clerk he shall be required to perform all the duties defined and set out as for City Tax Assessor, keeping all files and records of that officer. And the City Marshall of the City of Bonifay, Florida shall be vested with the authority of City Tax Collector, and in addition to the duties of City Marshall, he shall be required to perform all duties defined and set out for the City Tax Collector, keeping files and records of the officer.

Section 2. That any person hereinafter, bonded and appirented by the City Council, as City Clerk, shall authomatically be vested with the authority of City Tax Assessors, and required to perform all the duties defined and set out for the officer and his bond shall apply to the performances of such duties, whether specificly stated in appointment or not, and any person hereinafter bonded and appointed by the City Council as City Marshall, shall authomatically be vested with the authority of City Tax Collector and required to perform all the duties defined and set out for that officer, and his bond shall apply to the performance of such duties, whether specifically stated in appointment or not.

Section 3. This ordinance, shall become effective immediately upon its passage and approval, and Shall remain in full forde, until repealed, or toherwise changed by law.

Section 4. All ordinances, or resolutions, or parts of ordinances or resolutions, in conflict with the provisions of this ordinance is hereby repealed.
